Biographical Sketch-William Van Duzer Lawrence

1842, February 12	Born on a farm outside Elmira, New York.
1851-1862	Lawrence family moves to Monroe, Michigan; William attends Michigan Normal School in Ypsilanti; his father sells his farm and the Lawrence family disbands; Lawrence moves to Horseheads, New York, and works on his uncle Henry Van Duzer's farm; teaches school for a brief time in Veteran, New York.
1862	Moves to New York City to take a job with the wholesale drug business owned by his mother's cousin, S. R. Van Duzer.
1866-1888	Moves to Montreal, Canada, and works there briefly for S.R. Van Duzer's firm, then for Perry Davis & Son (soon renamed Perry Davis & Son & Lawrence, then Davis & Lawrence) and for a new firm which he establishes, Fellows Medical Manufacturing Company. Continues working for both firms for the rest of his life.
c. 1888-1892	Purchases a lot at the corner of 78 th Street and Fifth Avenue; engages architect Richard Morris Hunt to design a house; and moves into the new house—969 Fifth Ave.—in 1892.
1889, September	Travels from New York City to Bronxville to pick up his two sons who are staying with their aunt and uncle. Arthur Wellington shows Lawrence the 86 acre Prescott farm, which is for sale.

1890, May 20	Purchases the Prescott Farm and begins developing a residential community which he names Lawrence Park.
1890s-1920s	Makes other acquisitions of land in Bronxville and develops residential and commercial properties; also owns and/or develops properties in New York City, Chicago, Florida, and elsewhere. Forms a number of organizations to facilitate the management of his increasing real estate holdings, including The Lawrence Park Realty Company; Hotel Gramatan, Inc.; The Residents Company of Lawrence Park; The Village Investment Company; and several others.
1904-1906	Joins with another wealthy Bronxville resident, Frank Ross Chambers, to build and give a town hall to the Village of Bronxville.
1905	The Hotel Gramatan opens. It is an important feature of Bronxville for over sixty years.
1906-1909	Founds Lawrence Hospital in Bronxville with a gift of about \$250,000.
1906-1924	Distributes in phases to his four children most of the real estate he owns.
1916	Withdraws from the management of the properties he and his family own.
1917	Moves into "Westlands," his new home in Lawrence Park West, located just west of the Bronx River in Yonkers.
1921	Lawrence forms a company, Osceola Gardens, to develop a resort in Daytona Beach, Florida.
1926, December 13	Executes a deed giving his home in Yonkers, "Westlands," together with other real and personal properties to a new foundation, Sarah

Lawrence College. He adds additional bequests in his will, bringing his total gift to the college to about \$1,250,000.

1927, May 16 Lawrence dies at Lawrence Hospital in Bronxville; is interred in Kensico Cemetery, Valhalla, New York.

Collection Description

Most of the records of the business affairs of the William Van Duzer Lawrence family that are in this collection accumulated over a long period at 4 Valley Road in Bronxville, where the Lawrence family businesses for many years had their offices. The Bronxville History Center acquired the records in about 2003.

The collection has four series:

The Accounts Ledgers File, 1888-1927, consists of ten bound ledgers containing accounts relating to the Lawrence family's business enterprises. Lawrence apparently considered the first eight of these ledgers to belong to him, and he wrote himself all or most of the entries in the first three ledgers. Although most of the information in the ledgers consists of details of expenditure and income, there is also some information that is quite personal to Lawrence.

The Correspondence File, 1916-1918, contains two bound volumes of carbon copies of outgoing correspondence relating to Lawrence family real estate business; all, or perhaps almost all, the correspondence is written by William Van Duzer Lawrence and his two sons, Arthur and Dudley. Each volume contains about 1,000 pages; the first volume covers about 5¹/₂ months in 1916-1917, the second volume about 8¹/₂ months in 1917-1918.

The Subject File, 1888-1985, includes business records of forty companies through which the Lawrence family conducted their real estate business and other enterprises. These companies include, among others, Alden Place Corporation, Alger Court, Inc., Arthur Lawrence, Inc., W. L. Holding Corporation, Bronxville Lands, Inc., Dudley Lawrence Corporation, 48 Sagamore Corporation, 4 Valley Road, Inc., Hotel Gramatan, Inc., Ken-Court, Inc., Lawrence Investing Company, Inc., Lawrence Park Building Supply Company, Inc., Lawrence Park Realty Company, Milburn Properties, Inc., 110 Kraft Avenue Corporation, Osceola Gardens, Inc., Pondfield Sportcrafts, Inc., Rivermere-Southgate, Inc., Village Investing Company, Inc., and the Wrexham Road Co., Inc. The records for each of these companies typically includes a certificate of incorporation, bylaws, minutes of meetings, and sometimes a certificate of dissolution and some correspondence. In addition to these business records, the subject file includes files on aspects of the Lawrence's business, and sometimes their charitable activities. For example, there are files on litigation involving the Lawrence family, on a few individuals and non-Lawrence companies, and on Lawrence Hospital and Sarah Lawrence College. There is also in the series a photograph album depicting Lawrence properties, and a genealogical study of the Lawrence, Van Duzer, and Bates families.

The Property Records File, 1896-1977, includes files on properties owned by the Lawrence family including single-family houses, community housing developments (including Alden Place, Beechtree Lane, Bolton Gardens, Eastbourne, Field Court, Hillcrest, Kensington Terrace, Meadow Court, Merestone Terrace, Northgate, Rivermere, Gramatan Court, 48 Sagamore Road, Southgate, Stoneleigh, and Westbourne), commercial/residential buildings (including the Hotel Gramatan, Brick Row, 44 Pondfield Road, 49 Pondfield Road, 65 Pondfield Road), parcels of land, and other properties. The most common document types in the series are deeds, mortgagerelated documents, contracts, and correspondence.

Series Descriptions

Box Nos. Series

1-10 Accounts Ledgers File, 1888-1927

Ten bound ledgers containing accounts relating to the business enterprises of the Lawrence family, and to the personal side of the business affairs of William Van Duzer Lawrence. Lawrence appears to have considered the first eight of the ledgers in this series as belonging to him. The first three ledgers appear to be written entirely by him; several people, including Lawrence, wrote entries in the next five ledgers in the series. The eighth ledger in the series is the last containing information about Lawrence's business affairs, and it is unusual in the long date span—1905-1927 covered by its entries. It includes information about the many gifts Lawrence made late in life—to his children and the Village of Bronxville, and to found Lawrence Hospital and Sarah Lawrence College. The last two ledgers in the series contain accounts, respectively, of the Gramatan Stable Company and the Residence Company of Lawrence Park. Arranged variously by name of property, company, or individual; chronologically; or under general headings ("loans," "mortgages," "stocks and bonds," "expense," and others). About 2,700 pages in the ledgers in this series contain writing. Some of the ledgers contain indexes.

11-12 Correspondence File, 1916-1918

Two bound volumes containing carbon copies of outgoing letters. Almost all the letters relate to Lawrence family business, and almost all are signed by William Van Duzer Lawrence, Arthur W. Lawrence, or Dudley P. Lawrence. There is an index in the front of each volume. About 1,000 pages in each volume. Arranged chronologically.

13-22 Subject File, 1898-1985

Correspondence, minutes of meetings, bylaws, certificates of incorporation and dissolution, legal documents, stock certificates, a genealogy of the Lawrence, Van Duzer, and Bates families, and other documents relating to the business affairs of the family of William Van Duzer Lawrence. Arranged alphabetically, primarily by name of company, property, person, or subject.

23-35 Property Records File, 1896-1977

Arranged by property—stated usually as a building or development name ("Arcade Block," Bolton Gardens"), or as a street address or addresses ("1 Cedar Street," "11 and 22 Dusenberry Road")—and containing documents relating to the sale and purchase of properties, including deeds, contracts, correspondence, declarations of easements, survey maps, closing documents, and documents relating to mortgages.

Written primarily or entirely by assistants.]

Includes entries relating to Lawrence's gifts to his children and grandchildren and other individuals, and to the Village of Bronxville (Village Hall), Lawrence Hospital, and Sarah Lawrence College; the capitalization of and expenses relating to Osceola Gardens in Florida; and ownership changes of Lawrence's properties in Manhattan (residence at 969 Fifth Avenue, Hotel Leonori, Hotel Schuyler). Entries by several people, including Lawrence. 298 written pages. Entries made primarily by assistants, but a good number of entries made by Lawrence and some dictated by him.]

Odell was manager from this day until April 1904.
