### Resident Permit and Commuter Buyout Procedures

## PLEASE READ THE FOLLOWING REGULATIONS CAREFULLY AND SIGN THE CERTIFICATION PRINTED BELOW

**Please Note:** There will be a two week grace period from October 1 – 14, for placing your new **RESIDENT** and **COMMUTER BUYOUT PERMIT** on your vehicle provided your decal from the prior year is still affixed to your vehicle.

The **Resident permit** allows you the privilege to park in any of the Resident parking spaces in the Village of Bronxville – you are still required to abide by the parking space regulations and pay any meters accordingly. Please Note: Parkway Road Lot is not available to Resident permit holders without a Commuter Buyout Monday – Friday.

A **Commuter Buyout permit** is a pre-payment of the parking meter valid **ONLY** in the specific parking lot for which the permit is purchased.

A parking space in the Kraft Lot and Kensington Garage is not guaranteed at any given time. If there are no available parking spaces in the parking lot of your designated parking permit, your **RESIDENT** permit allows you to park in other Resident parking spaces throughout the Village, however you will need to pay the meter.

#### Eligibility for Permit

Resident permits will be issued **ONLY** to individuals who reside within the boundaries of the Village of Bronxville provided they have no unpaid tickets in the village. If your vehicle is not registered in Bronxville, proof of residency will be required.

#### Other Restrictions

**Parkway Road Lot buyout permits CANNOT be purchased for vehicles with Overnight permits.**

#### Term of Validity

A permit is valid through its expiration date or until the holder is no longer a resident of the Village, whichever occurs first.

#### New Car - Change of Vehicle

Permits are issued according to license plates, and are **NOT** transferrable to other vehicles. If a permit holder changes vehicles or license plates, the original permit **must** be returned to Village Hall in order to obtain a replacement. A replacement will be issued for \$5.00 in accordance with the same procedures for obtaining a permit above.

#### Temporary Change of Vehicle

If your vehicle is temporarily not available for you to use, you may receive a temporary permit for your **RESIDENT** permit only with the appropriate documentation. If you have a Commuter Buyout for that unavailable vehicle, we will mark the temporary permit that it can be used in conjunction with that buyout. If the buyout is not affixed to your temporary vehicle next to the temporary permit, you must feed the meter.

#### Lost Permits

If a permit is lost, a Lost Permit Affidavit must be submitted to the Parking Office at Village Hall. A replacement will be issued for \$5.00 in accordance with the same procedures for obtaining a permit above. If the Commuter Buyout permit is lost, a police report must be filed and submitted with a lost permit affidavit before a replacement permit can be issued.

## Certification by Village Resident Applicant

Pursuant to the provisions of the Village Ordinance regulating parking, the undersigned, who resides within the corporate limits of the Village of Bronxville and who will be the driver of the motor vehicle described above, hereby makes application for the issuance of a permit to park said vehicle in the parking area designated in said ordinance when space therein is available.

The undersigned agrees that the Village of Bronxville will not be liable for any loss or damage to the above-described motor vehicle or its equipment occurring while such motor vehicle is parked in any parking area in said Village. It is understood that the Village of Bronxville does not, directly or indirectly guarantee, by the issuance of the permit herein applied for, that there will be parking space available in the parking areas designated in said ordinance.

It is also understood and agreed that no refunds will be issued solely due to unavailability of a parking space. Knowingly making a false written statement is punishable as a Class A misdemeanor pursuant to New York State Penal Law ("Penal Law") Section 210.45. Submission of any forged or falsified written instrument is punishable under Penal Law Article 170 and may be punishable under other provisions of the Penal Law and federal law. Any permit illegally obtained will be revoked. By submitting this application, I certify that the information contained in this application, and the supporting documents, are true and correct.
