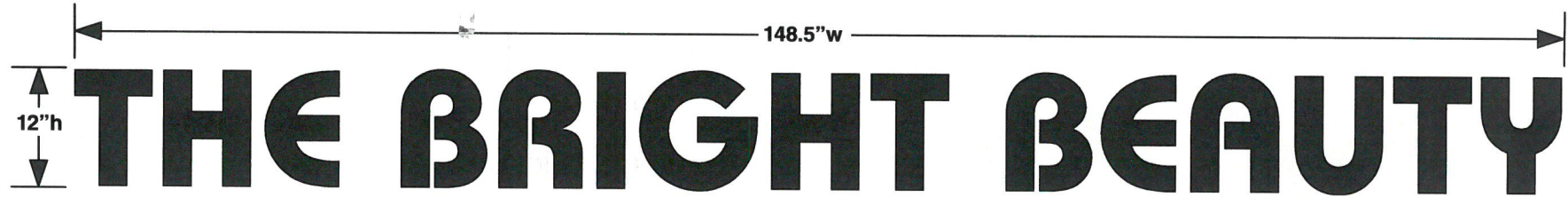

POST ON ENTRANCE DOOR OF PROPOSED LOCATION



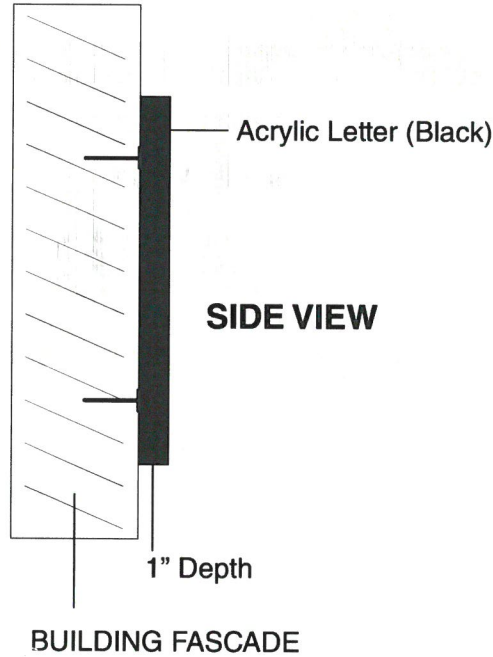

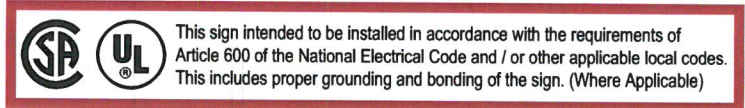

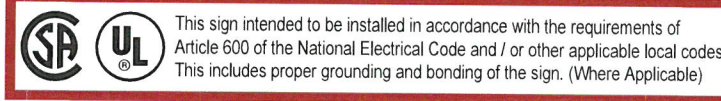
