Acting Chairman Reetz called to order the regular meeting at 7:31 PM.

APPROVAL OF MINUTES

On motion of Mrs. Smith second by Mrs. Atayan, the Board approved the minutes of the Regular Meeting on June 8, 2016.

SITE PLAN APPROVAL FOR 71 PONDFIELD RD – SPRINT – WIRELESS TELECOMMUNICATION FACILITY

Mr. Robert Gaudio, from Law firm of Snyder and Snyder, spoke on behalf of Sprint requesting approval for a wireless telecommunications facility. He requested approval for an antenna and equipment installation (3) panel antennae and (3) equipment cabinets and a 24" microwave dish within the existing enclosure utilizing the existing support structure at the former Metro PCS location. He explained the screening wall will remain the same as well as the number of antenna. He stated all testing was done to make sure it was in compliance.

Mr. Reetz asked if the antennae were the same as the previous ones at the existing area.

Mr. Gaudio explained there are three antennae on the same pole.

Mrs. Atayan stated that this is a common application in the area and this is a practical setup due to it taking the place of what was existing.

Mr. Mike Musso from HDR spoke on his study on the above project. He stated he had comments that the applicant addressed before the meeting. He spoke of his report and maps that were given to the Board on this application. He stated of the recommendations that were given to the Board.

Mrs. Maureen Hackett spoke on behalf of the DRC Committee. She stated that the antennae were not visible from the street.

Mr. Reetz opened the Public Hearing at 7:53, seeing no further comments Mr. Reetz closed the Public Hearing.

On the motion of Mrs. Atayan, second by Mr. Murray the Planning Board approved this application FOUR to ZERO subject to meeting the recommendations from HDR.
