LETTER FROM THE CHIEF

Dear Resident,

I am proud and excited to present the first Bronxville Police Department Annual Report. This report documents and highlights some of the activities of the department throughout 2021. This past year continued to be a difficult one as we faced many challenges related to the Covid-19 pandemic. Our Officers continue to perform at an exceptional level assisting you, our merchants and visitors and we look forward to advancing even more initiatives in 2022.



In accordance with Governor Cuomo's Executive Order 203 (the NYS Police Reform and Reinvention Collaborative) dated June 2020, the Village established its Police Community Relations Committee (PCRC) and charged it with engaging in a fact-based, honest dialogue concerning the public safety needs of our community and to create a plan to adopt and implement the recommendations resulting from its review and consultation. The Village established a diverse committee of stakeholders who engaged in a dialogue and analysis about the public safety needs of our community, reviewed the Bronxville Police Department (BPD) policies and discussed the relationship between the BPD and the community it serves. The entire department welcomed the process. In March of 2021, the Village Board adopted the report of the PCRC and the Police Department went to work immediately to implement the recommendations. This report details many of the changes that were executed. We are exceptionally proud of our community outreach initiatives detailed in the report and look forward to more events in 2022.

We rely on support and assistance from our neighbors in Eastchester and Tuckahoe and expanded our partnerships with the Eastchester and Tuckahoe Police Departments, not simply for community events but for expanded training opportunities. Bronxville Police Department Instructors hosted de-escalation training and active shooter training for members of all three departments.

I am exceedingly thankful to each and every member of the Bronxville Police Department. Members of the department continue to proudly and honorably serve the community. I am grateful for the unwavering support of the Mayor, Board of Trustees and Village Administrator as well as the incredible support from you and our merchants. As Hall of Fame basketball player Dominique Wilkins said, "You are only as good as your team." We have assembled an incredibly talented and dedicated team and the impressive accomplishments throughout the past year are a direct result of their hard work and dedication. We will continue to work each and every day to build trust and strengthen relationships.

DEPARTMENT OVERVIEW

The Village of Bronxville Police Department, under the command of Chief of Police Christopher Satriale, is a state-of-the-art, professionally staffed law enforcement department dedicated to providing optimal services for all village residents and those who visit or do business within our environs.

Through comprehensive, preventative measures, the department is vigilant in its efforts to maintain a lawful and peaceful atmosphere, thereby helping to facilitate a high quality of life for all residents.

The department, comprised of twenty-three dedicated individuals, staffs a chief of police, one lieutenant, one detective sergeant, one detective, five uniformed sergeants and fourteen police officers. In addition to the continual patrol and crime prevention measures undertaken throughout the day and night, the police department provides prompt and courteous service for a wide variety of situations.

VILLAGE GOVERNMENT OVERVIEW

Mayor & Board of Trustees

The Village of Bronxville is governed by a five member Board of Trustees.

The Board consists of a Mayor and four Trustees. The Mayor is the Chief Executive Officer of the Village and is responsible for the conduct of public meetings and certain appointments. The Mayor and Trustees all have one equal vote for the adoption of resolutions. In addition, they also serve as the Board of Police Commissioners and as such, are charged with the authority to oversee the Police Department.

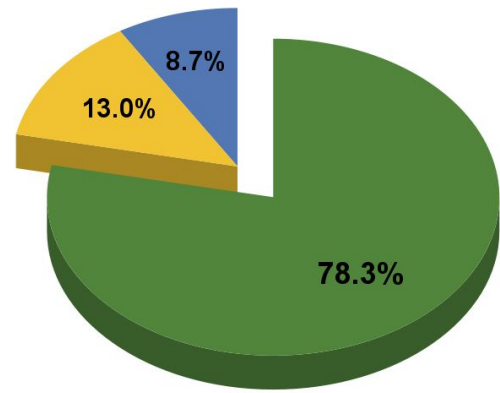

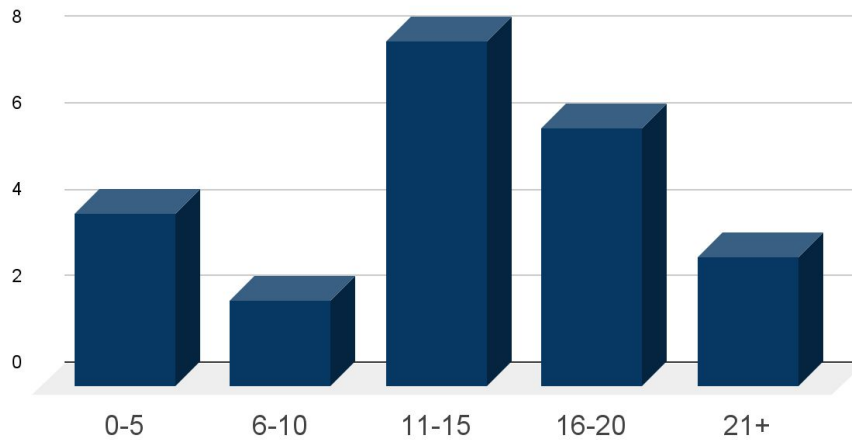

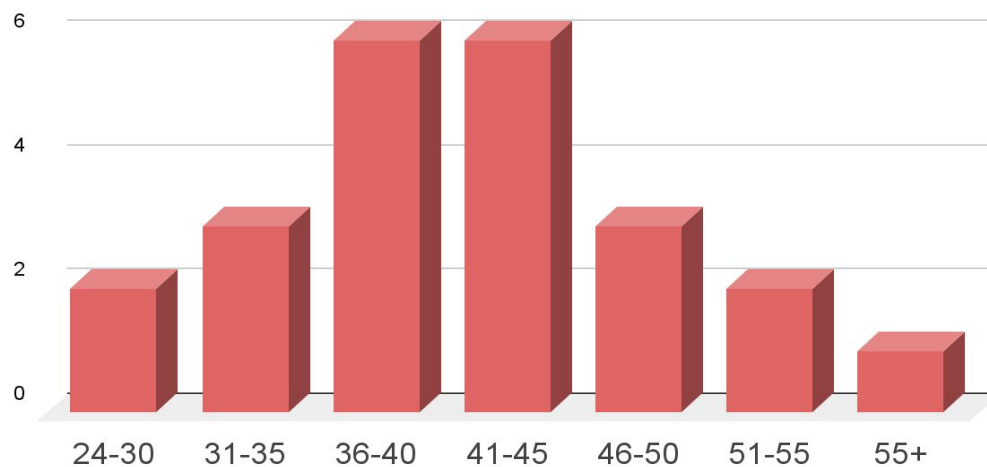

PATROL DIVISION

The Bronxville Police Department maintains several divisions and units. The Patrol Division is the most visible component of the department. The main objective of the Patrol Division is to execute law enforcement responsibilities through preventative patrol and active enforcement of criminal and traffic laws, emergency assistance, public information and alleviating public hazards.

DETECTIVE DIVISION

The Detective Division conducts follow up investigations and maintains continual contact with other area police departments and the Westchester County District Attorney's Office. Through such mutual access with other law enforcement agencies, the detective division is able to monitor possible crime trends and suggest preventive measures, while availing the department of the latest developments in investigative techniques. Additionally, the detective division delivers crime prevention lectures to various groups and security surveys for residences and businesses.



EMERGENCY RESPONSE UNIT

The multi-jurisdictional Emergency Response Unit is a highly trained and skilled tactical team used as a resource in the handling of critical incidents. The unit is comprised of members from the Bronxville, Tuckahoe, Eastchester and Pelham Police Departments. The unit has received certification from The New York State Division of Criminal Services after meeting and exceeding all accreditation standards.

BICYCLE PATROL UNIT

The Bicycle Patrol Unit remains quite popular with residents, merchants and visitors to Bronxville. Bicycle patrol enables each assigned officer to personally interact with the public and provides officers the opportunity to become particularly familiar with their surroundings.

YOUTH DIVISION

The Bronxville Police Department is keenly aware of the issues and dilemmas facing today's youth, and specially trained officers administer to these problems for our younger residents. From youth crime to resolving non-criminal matters, the youth division can provide invaluable assistance and direction.

ADMINISTRATION



CHIEF CHRISTOPHER SATTRIALE began his career in 1988 with The Bronxville Police Department. He was appointed chief in 2007 and has proudly worn every shield in the department's ranks including police officer (1988), detective (1992), sergeant (1995), detective sergeant (1999) and lieutenant (2003).

Chief Satriale is a member of many law enforcement organizations including: The FBI Law Enforcement Executive Development Association, The International Chiefs of Police Association, The New York State Chiefs of Police Association, The Westchester County Chiefs of Police Association, The NYS Juvenile Officers Association, The Bronxville School Health and Safety Committee and The Pleasantville Dads Club.

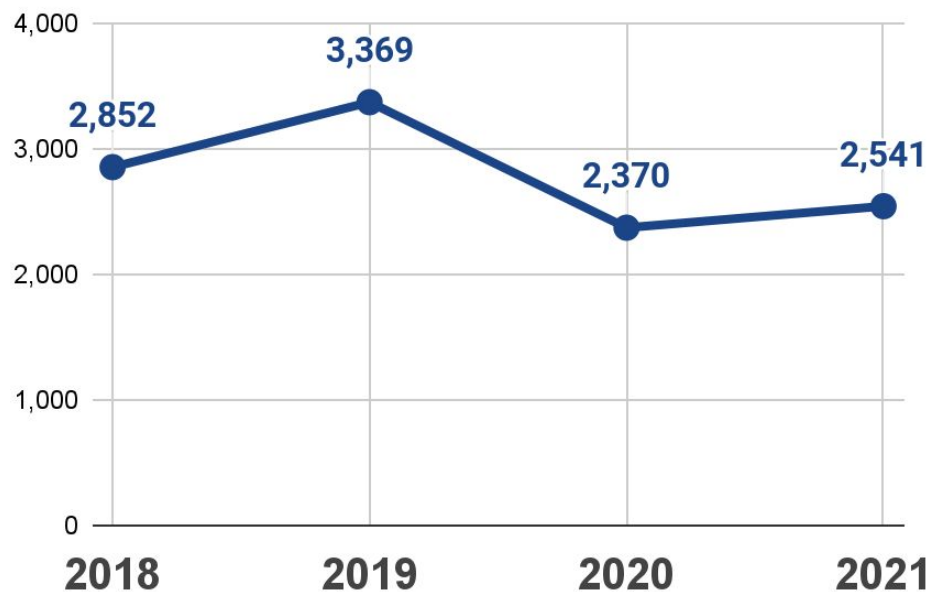

POLICE COMMUNITY RELATIONS COMMITTEE

In accordance with former Governor Cuomo's Executive Order 203 (the NYS Police Reform and Reinvention Collaborative) dated June 2020, the Village established its Police Community Relations Committee (PCRC) and charged it with engaging in a fact-based and honest dialogue about the public safety needs of our community and to create a plan to adopt and implement the recommendations resulting from its review and consultation.

Membership:

The members of the PCRC were chosen to represent a wide array of constituents across the Village, ranging from clergy, merchants, residents, students, police officers and members of the judiciary. *Please visit the Village website for a full list of members.*

Responsibilities/Objectives:

The PCRC held multiple meetings with members of the Bronxville Police Department (BPD) and with the public to discuss any issues or concerns they may have had. In general, the committee found the BPD to be well respected and engaged with the community, well managed, well trained and well governed. The PCRC also concluded that like any well run organization, the BPD must continually self-examine and seek avenues for improvement.

POLICE COMMUNITY RELATIONS COMMITTEE

Recommendations:

Enhance the Community's Understanding and Awareness of the Activities and Policies of the BPD:

- Make monthly statistics available on the Village website
(Statistics have been made available on the Village website)
- Post ten year history of statistics on the Village website
(Statistics have been made available on the Village website)
- Update civilian complaint form and make it readily accessible
(Updated civilian complaint and compliment forms are available on the Village website)
- Re-institute the Village Government, BPD and Student Government Committee (with parental representation) to help develop and strengthen the bonds between our younger residents and the BPD
(Chief Satriale and Sergeant DeYoung have had multiple meetings to address issues such as underage drinking and substance abuse)

POLICE COMMUNITY RELATIONS COMMITTEE

Enhance the Community's Understanding and Awareness of the Activities and Policies of the BPD: (continued)

- Establish a liaison with the new Iona College administration and student body to engage in discussions regarding safety, security and other matters not related to the BPD

(Sergeant DeYoung has been designated as the liaison between BPD and Iona College administration)

- Complete an Annual Report of the BPD highlighting training activity, use of force statistics, civilian complaints and their outcomes, staffing changes, new policies and accomplishments

Enhance Officer Training:

- Implement Lexipol Policy Management and training programs to ensure that all members of the BPD are current on all changes in law and practices and ensure proper oversight and enforcement of training

(Lexipol Policy Management and PoliceOne Academy, both online law enforcement training resources, are currently being used by the BPD)

POLICE COMMUNITY RELATIONS COMMITTEE

Enhance Officer Training: (continued)

- Expand training programs: OC/Pepper Spray and less lethal training, expand de-escalation training, expand training to include the Village of Tuckahoe and Town of Eastchester Police Departments

(OC/Pepper Spray, less lethal and de-escalation training has been completed by all officers of the BPD. Training continues with Tuckahoe and Eastchester Police Departments)

- Require all officers to complete Implicit Bias training

(Implicit Bias training completed by all members of the BPD)

- Leverage resources with neighboring communities and outside agencies for mental health needs, domestic violence and substance abuse

(BPD has been in contact with members of the Westchester Crisis Stabilization Team for individuals needing assistance with mental health or domestic violence issues. Contact has also been made with local recovery facilities)

**There may be more than one type of force used in the same incident and more than one officer involved in a single incident, therefore the number of types of force and the number of officers involved may be higher than the number of incidents.*

CIVILIAN COMPLAINTS/OUTCOMES

It is essential that the community have confidence in the administrative procedures of the department designed to supervise the exercise of police power. If the integrity and efficiency of the department are to be maintained, allegations of misconduct against members of the department must be thoroughly and expeditiously investigated. At the same time, the department recognizes that members are often subjected to intense pressures in the discharge of their duties. They are frequently required to remain neutral under circumstances that are likely to generate considerable tension, excitement and emotion. In such situations, words, actions and events occasionally result in misunderstandings and confusion. It is to the advantage of each member that the department has sound internal procedures for the investigation of allegations arising out of such circumstances. The expeditious resolution of complaints fairly and impartially will insure that the high level of integrity and efficiency enjoyed by the department is maintained.

It is the policy of The Bronxville Police Department to investigate all complaints of alleged officer misconduct, determine the validity of complaints promptly and impartially and to take appropriate action, when necessary, based on such a determination.

In 2021 there was one civilian complaint filed against a Bronxville police officer. The complaint resulted in no finding of misconduct by the officer.



DEPARTMENT TRAINING

Unified In-Service Training was held in (2) 8 hour blocks conducted by Westchester County Police Academy staff. Topics covered included Taser-Defensive Tactics-Cardiopulmonary Resuscitation(CPR) & Automated External Defibrillator(AED)-Occupational Safety and Health Act(OSHA)-Public Employee Safety and Health Bureau(PESH)-Blood Borne Pathogens-Personal Protective Equipment(PPE)-Hazardous Materials (HAZMAT)-Fire Extinguisher Use-Domestic Violence Lethality Assessment Program- Introduction to Procedural Justice 1, 2 & 3-Use of Force-Article 35 Review

De-Escalation Training was held in conjunction with The Tuckahoe Police Department. All officers completed a multi-day qualification course which comprised of classroom instruction focused on de-escalation tactics and techniques, OC spray, pepperball less lethal launcher and CPR/AED/naloxone refresher. This training was followed by force-on-force scenario based training. This scenario based training allowed our officers to be put through situations where they were able to employ de-escalation tactics, as well as, reinforcing other tactics & techniques to increase officer safety.



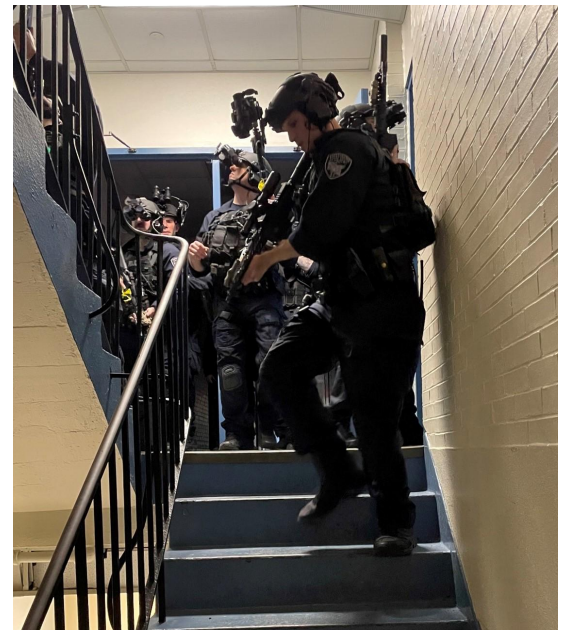
DEPARTMENT TRAINING

Taser Training Every officer is trained and certified in the safe carry and use of the Taser x26p conducted energy weapon. The Taser x26p is a less lethal weapon that allows officers an additional force option to control violent or resisting suspects. Officers are required to recertify with the Taser x26p annually.

Active Shooter Training was held in conjunction with The Tuckahoe and Eastchester Police Departments. Officers were trained in active shooter response tactics, as well as, county wide mutual aid protocols. Officers were able to safely and effectively integrate their response with neighboring agencies. The training culminated in force-on-force scenarios to test tactics learned.

Department Range Qualifications was held in March, June, September and November. Officers completed training and qualification in their department issued Glock duty weapon, off duty firearms and department patrol rifles. Training included safe handling of, and proficiency in, handguns and patrol rifles. Officers also qualified on the pepperball less lethal launcher system.

SPECIALIZED TRAINING



The Emergency Response Unit performed training throughout the year. Tactical training included use of night vision goggles(NVG), firearms training including the use of firearms with NVG, structure clearing tactics, force-on-force simunitions training and teaching active shooter response at The Westchester County Police Academy Swat School. Training also included less lethal weapons qualification, high-risk warrant planning and inter-municipal training with Metro North Police Emergency Service Unit. Training with Metro North Police covered tactical response to situations on trains (tubular assaults), active shooter response, combat leadership and barricaded suspect resolution.

SPECIALIZED TRAINING



Select officers of the department attended the following training over the course of the year:

Force Science De-Escalation Training – taught concepts and methods that support de-escalation between officers and subjects

Chemical Aerosol (Oleoresin Capsicum) Instructor Course – topics covered include Oc Formulations, Delivery Systems, Effectiveness, Safety, Deployment Methods, Decontamination and First Aid For Exposures

Pepperball Instructor/Armorer Course – the pepperball weapon system is a non-lethal chemical agent delivery system that uses high pressure air to deliver pava powder projectiles from a safe distance

Taser Instructor Course – officers were certified by Taser to instruct new and recertify users in certain models

Tactical Emergency Casualty Care – this course covered the strategies for hemorrhage control, including the use of tourniquets and hemostatic dressing, airway control techniques and treating indicators of shock

SPECIALIZED TRAINING



Breath Analysis Operator Course – Department of Criminal Justice course taught the concepts and principles of breath alcohol testing

Community Resource Officer – topics included Implementing And Promoting The Cro Concept, Community Policing, Implicit Bias, De-Escalation Techniques, Understanding Mental Health/Special Needs, Presentation Skills, Communication Skills, Social Media Crimes and Tools For CRO Promotion, Record Keeping, Developing Community Events and Current Trends in the Community

Critical Asset Risk Management – taught the critical components of risk management and provided participants the basic fundamentals of determining and mitigating risks associated with their critical infrastructure

FBI LEEDA Command Leadership Institute – course is designed to prepare law enforcement leaders for command level positions. Topics covered included Credibility, Command Discipline and Liability, Dealing With Problem Employees and Leading Change Within An Organization

TRAINING CONFERENCES

FBI LEEDA Executive Training Conference - training included courses on Procedural Justice, Serving in the 21st Century, Contemporary Issues In Law Enforcement, Police Wellness Programs, Hiring and Retention, and Motivating and Empowering Leaders

State Of New York Juvenile Officers Association Conference - training included courses on Advanced School Resource Officer, Community Resource Officer, Advanced Juvenile Officer, Continuing Education Workshop Series with classes covering Responsive Leadership, Legal Updates, Threat Assessment Teams and Identifying Drug Trends In Schools

New York Tactical Officers Association Conference - training included Plain Clothes Handgun Tactics, Active Threat Incidents, Building Clearing Tactics and Two Officer Apprehension Tactics

Law Enforcement Training Directors Association Of New York State Conference - training and seminars were held on contemporary legal issues for police trainers, use of force training, officer wellness and procedural justice initiatives

LEXIPOL AND POLICEONE ACADEMY TRAINING

The Bronxville Police Department began augmenting its training program with online training through Policeone Academy. Policeone Academy allows officers to complete relevant and comprehensive training in a wide array of topics on an online platform. This allows our officers to train with greater frequency.

COVID-19
