LETTER FROM THE CHIEF

Dear Resident,

I am proud to present the Bronxville Police Department Annual Report for 2023. This report documents and highlights some of the activities of the department throughout 2023.

This past year saw many changes in the Police Department including the well-deserved retirement of Lieutenant Richard Bunyan after 41 years in law enforcement. His retirement resulted in several promotions highlighted within the report. Our Officers continue to perform at an incomparable level assisting you, our merchants and visitors and we look forward to introducing even more initiatives in 2024.

In 2023, we advanced full implementation of Lexipol's library of law enforcement policies that enhance compliance, professionalism and transparency. We continued to improve our training opportunities by expanding our in-person training. In 2023, our Officers received more than 4000 hours of training - our certified instructors conducted much of this training in our training room. We expect to train additional instructors in 2024 to assist in our in-service training programs.

In order to continue to provide first-rate service, we trained an additional two Officers to be Emergency Medical Technicians (EMT) bringing our total EMT's to five. Considering we were the first on-scene personnel for more than 360 medical calls last year, the EMT training provides critical care for patients within minutes of the call for service. A summary of some of our impressive training is included within the report.

In 2023, we responded to nearly 3,000 calls for service - a slight increase over our 2022 totals. The calls ranged from response to burglar alarms, auto accidents and criminal investigations. A chart of our calls for service is contained within the report as well.

We continued to focus on community relations hosting several events as well as attending some hosted by community partners. We are exceedingly proud of our efforts supporting the Village's 125th Anniversary celebration. Members of the department provided tours of police headquarters, demonstrated the use of our equipment and staffed the barbecue grill serving more than 350 cheeseburgers and 400 hot dogs to those attending the celebration.

Our partnership with our neighbors in Eastchester and Tuckahoe remains strong. We participated with both departments in National Night Out – an annual community-building campaign that promotes police-community partnerships and neighborhood camaraderie.

To the members of the Bronxville Police Department, thank you for your sustained commitment to the Village and exemplary service to our community. As always, we remain appreciative to the Mayor, Board of Trustees and Village Administrator for the vital support they continue to provide. Additionally, our merchants consistently provide much needed care and appreciation for our members.

We ended 2023 under tragic circumstances – the continued support from the entire Village and surrounding communities is overwhelming and reassuring – as Winston Churchill said, “If you're going through hell, keep going.” My team is committed to the future beyond this tragedy and strength drawn from these difficult times.

DEPARTMENT OVERVIEW

The Village of Bronxville Police Department, under the command of Chief of Police Christopher Satriale, is a professionally staffed law enforcement department dedicated to providing optimal services for all village residents and those who visit or do business within our environs.

Through comprehensive, preventative measures, the department is vigilant in its efforts to maintain a lawful and peaceful atmosphere, thereby helping to facilitate a high quality of life for all residents.

The department, comprised of twenty-one dedicated individuals, staffs a chief of police, one lieutenant, one detective sergeant, one detective, five uniformed sergeants and twelve police officers. In addition to the continual patrol and crime prevention measures undertaken throughout the day and night, the police department provides prompt and courteous service for a wide variety of situations.

VILLAGE GOVERNMENT OVERVIEW

The Village of Bronxville is governed by a five member Board of Trustees.

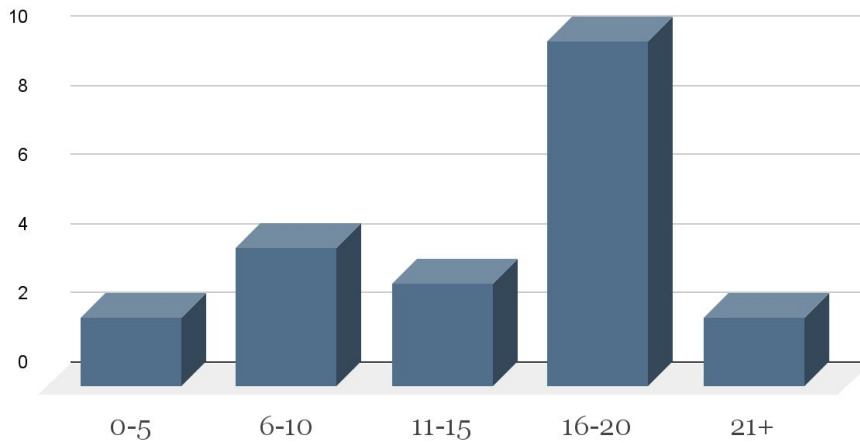

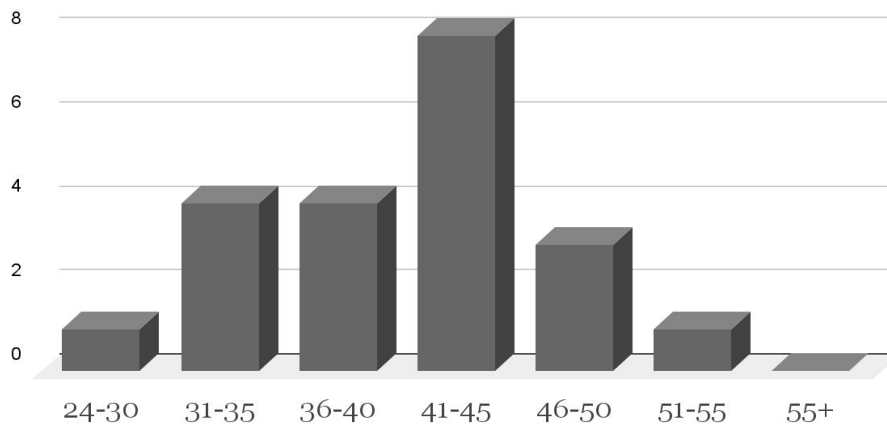

PATROL DIVISION

The Bronxville Police Department maintains several divisions and units. The Patrol Division is the most visible component of the department. The main objective of the Patrol Division is to execute law enforcement responsibilities through preventative patrol and active enforcement of criminal and traffic laws, emergency assistance, public information and alleviating public hazards.

DETECTIVE DIVISION

The Detective Division conducts follow up investigations and maintains continual contact with other area police departments and the Westchester County District Attorney's Office. Through such mutual access with other law enforcement agencies, the detective division is able to monitor possible crime trends and suggest preventive measures, while availing the department of the latest developments in investigative techniques. Additionally, the detective division delivers crime prevention lectures to various groups and security surveys for residences and businesses.



EMERGENCY RESPONSE UNIT

The multi-jurisdictional Emergency Response Unit is a highly trained and skilled tactical team used as a resource in the handling of critical incidents. The unit is comprised of members from the Bronxville, Tuckahoe, Eastchester and Pelham Police Departments. The unit has received certification from the New York State Division of Criminal Services after meeting and exceeding all accreditation standards.

BICYCLE PATROL UNIT

The Bicycle Patrol Unit remains quite popular with residents, merchants and visitors to Bronxville. Bicycle patrol enables each assigned officer to personally interact with the public and provides officers the opportunity to become particularly familiar with their surroundings.

YOUTH DIVISION

The Bronxville Police Department is keenly aware of the issues and dilemmas facing today's youth, and specially trained officers administer to these problems for our younger residents. From youth crime to resolving non-criminal matters, the youth division can provide invaluable assistance and direction.

CHIEF CHRISTOPHER SATTRIALE began his career in 1988 with The Bronxville Police Department. He was appointed chief in 2007 and has proudly worn every shield in the department's ranks including police officer (1988), detective (1992), sergeant (1995), detective sergeant (1999) and lieutenant (2003).

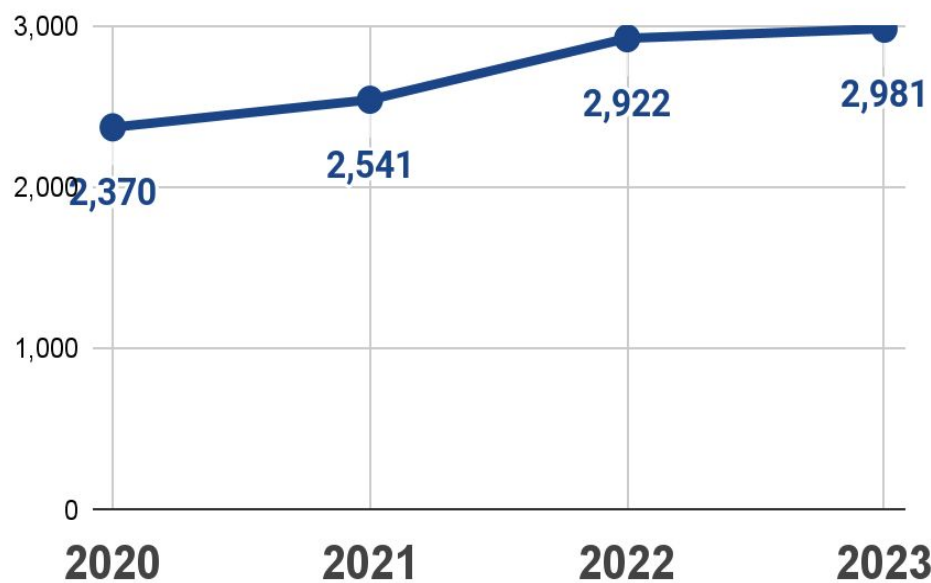

CIVILIAN COMPLAINTS/OUTCOMES

It is essential that the community have confidence in the administrative procedures of the department designed to supervise the exercise of police power. If the integrity and efficiency of the department are to be maintained, allegations of misconduct against members of the department must be thoroughly and expeditiously investigated. At the same time, the department recognizes that members are often subjected to intense pressures in the discharge of their duties. They are frequently required to remain neutral under circumstances that are likely to generate considerable tension, excitement and emotion. In such situations, words, actions and events occasionally result in misunderstandings and confusion. It is to the advantage of each member that the department has sound internal procedures for the investigation of allegations arising out of such circumstances. The expeditious resolution of complaints fairly and impartially will insure that the high level of integrity and efficiency enjoyed by the department is maintained.

It is the policy of The Bronxville Police Department to investigate all complaints of alleged officer misconduct, determine the validity of complaints promptly and impartially and to take appropriate action, when necessary, based on such a determination.

In 2023 there were 4 civilian complaints filed against Bronxville police officers. The complaints resulted in no findings of misconduct by the officers.



DEPARTMENT TRAINING

In-Service Training

Department Range Qualifications - held in March, June, July and September. Officers completed training and qualification in their department issued Glock duty weapon, off duty firearms and department patrol rifles. Training included safe handling of, and proficiency in, handguns and patrol rifles.

CPR, AED, NALOXONE - every Officer was recertified in CPR, the use of the AED, Automated External Defibrillator, and Naloxone.

Mobile Crisis Response Team Training - training was held with representatives of the the Westchester County Mobile Crisis Response Team who work in conjunction with Police Departments to offer community-based interventions to individuals in crisis. The Team offers assistance with triage/screening for suicidality or need for hospital transport, de-escalation and conflict resolution, peer support, coordination with medical and behavioral health services and crisis planning and follow-up. Team clinicians can respond to persons in crisis calls with the police, or on their own if the person is deemed not a threat to safety.

SPECIALIZED TRAINING

New York DCJS Basic Course for Police Officers - In January, Officer Kevin Iglesias began his Basic Course for Police Officers at the Westchester County Police Academy. The course is a New York State DCJS certified 21 week academy that certified officer Iglesias as a Police Officer.

FBI National Academy - Lieutenant DeYoung attended training hosted by the FBI National Academy. Topics covered included leadership tactics and strategies for tumultuous times, meeting the leadership challenges of law enforcement first-line supervision and mastering the leadership challenges of law enforcement.

New York State Supervisor's School - Sergeant Lewis completed the New York State mandated Supervisor's school. The school encompasses many topics that supervisors face daily from incident command to issues that may arise in patrol.

Field Training Officer Course - Lieutenant DeYoung attended the New York State DCJS Field Training Officer course at Westchester County Police Academy. This course certified Lieutenant DeYoung as a Field Training Officer and will allow him to oversee our Field Training Program.

Accreditation Management Course - Lieutenant Carroll completed a course through John Jay College of Criminal Justice outlining the process and procedure for initiating and completing the accreditation process.

SPECIALIZED TRAINING

The Emergency Response Unit - performed tactical training which included covert searches, team movement, high-risk warrant service, active shooter response, structure clearing strategies and less lethal weapons use and certification, advanced firearms training, close-quarter tactics and active shooter responses.

New York State DCJS SWAT School - Officer Stein and Officer Sokol attended the DCJS New York State SWAT Operator course hosted by Westchester County Police. Officers have become certified SWAT Operators and members of the joint Emergency Response Unit of Bronxville PD, Tuckahoe PD and Eastchester PD.

Taser Instructor Certification - Sergeant Lewis, Officer Cooper and Officer Sokol attended a Taser Instructor Certification Course at the Westchester County Police Academy.

PepperBall Instructor - Lieutenant DeYoung, Sergeant Lewis and Officer Cooper attended an Instructor/Armorer course to recertify as PepperBall Instructors. The course allows the officers to certify users in the PepperBall non-lethal weapons system.

DCJS Radar Operator Course - Officer Iglesias attended a DCJS Radar Operator Certification Course at the Westchester County Police Academy.

SPECIALIZED TRAINING

SFST Training - Officer Sokol attending training where he was taught the process of conducting Standardized Field Sobriety Tests (SFST) that are to be completed where there is suspicion that the operator of a vehicle may be under the influence.

Investigative Photography Course - Detective Jarosz attended the Investigative Photography course at the Westchester County Police Academy where she was instructed and informed on different types of equipment and how it will be used when taking photos at crime scenes.

CODIS Training - Detective Valentin and Detective Jarosz attended training at the Westchester County Forensic Laboratory that focused on using the Combined DNA Index System (CODIS), an investigative tool to aid in law enforcement investigations.

Crime Scene & Evidence Course - Detective Jarosz attended the Crime Scene and Evidence Course at the Westchester County Police Academy that addressed the evaluation process of a crime scene along with the preservation, collection, and submission of evidence.

SPECIALIZED TRAINING

Select officers of the department attended the following training over the course of the year:

Emergency Medical Technician (EMT) School - Officers have completed a 4 month EMT certification program at Scarsdale Volunteer Ambulance Corps and some with The New Rochelle Fire Department. Upon passing all necessary exams, Officers will be certified as EMTs in the State of New York.

Use of Force Refresher Course - the course covered updates to the laws and practices governing use of force in the state of New York. Topics covered included understanding and applying the constitutional requirements for police use of force, Penal Law Article 35's interpretation and role in training, force investigations, human performance issues and their implications, supervisory responsibilities, and proper report writing.

De-Escalation Training - Officers attended a two day in-service training at the Westchester County Police Academy focusing on the de-escalation process and how it can be implemented and utilized in a patrol capacity.

Officer Wellness Summit - Officers attended the Law Enforcement Wellness Summit hosted by Guardian Revival. The event was designed to provide holistic insights and advice to help level up health, wellness and leadership skills.

TRAINING CONFERENCES

FBI LEEDA Internal Affairs Investigator Course - this course focused on best practices related to effective internal control mechanisms calculated to promote enhanced agency accountability. Course topics included policies and procedures, effective complaint processes, investigation of personnel complaints, administrative law, and disciplinary due process to promote proper, safe decision-making and provide for defensible outcomes in all phases.

Tactical Team Leader Conference - topics covered included debriefs and case studies of various high risk tactical situations throughout the state and the country, the current threat environment, an overview of the tactical bomb technician program, preparing for presidential visits, FBI SWAT updates from New York State, regional discussion of contemporary issues within tactical operations and cultural growth – building a team culture of excellence.

Law Enforcement Training Directors Association of the State of New York Conference - the conference focused on sharing new training techniques and best practices amongst training directors and training staff throughout New York State. Topics covered included Redesigning Firearms Training, The Four Pillars of Leadership, Contemporary Legal Issues for Police Trainers and Methods of Instruction.

TRAINING CONFERENCES

FBI LEEDA Command Leadership Institute - the training is designed to prepare officers for command level positions. Topics covered included command discipline and liability, credibility, dealing with problem employees and leading change within an organization.

FBI Law Enforcement Executive Development Seminar - this seminar is designed to provide leadership training for police chiefs and higher-ranking law enforcement executives who are in leadership positions in departments. This highly successful and selective program provides insight into some of the many challenges facing today's police executives. The curriculum covered Leadership, Domestic Terrorism, Crisis Communication, Officer Wellness and Emotional Survival for Law Enforcement.

New Jersey State Police Homicide Investigators Conference - topics covered included Interview and Interrogation, Behavioral Analysis, Crime Scene Reconstruction, Advancements in Digital Evidence, Forensic Pathology, as well as major cases studies.

DCJS Public Safety Symposium - speakers were researchers, academics, and practitioners who are at the forefront of the field of law enforcement practices.

TRAINING CONFERENCES

New York State Association of Chiefs of Police Conference – topics covered included legal updates about trends in cases involving the use of force, both locally and nationally. Leadership development focuses on problem-solving, project planning and delegation, and improving overall employee well-being. Safe restraint techniques were also covered for dealing with an agitated individual.

New York State Association of Chiefs of Police Leadership Summit – brings members of the law enforcement community together to discuss various topics that affect the profession.

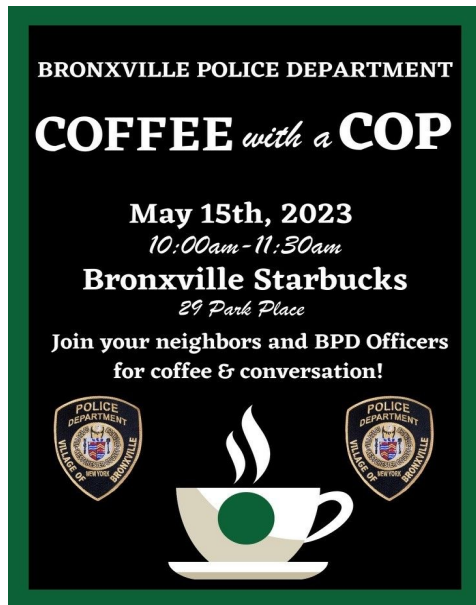

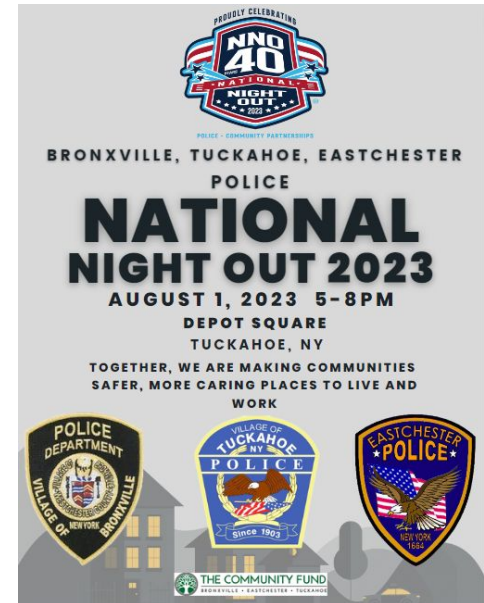

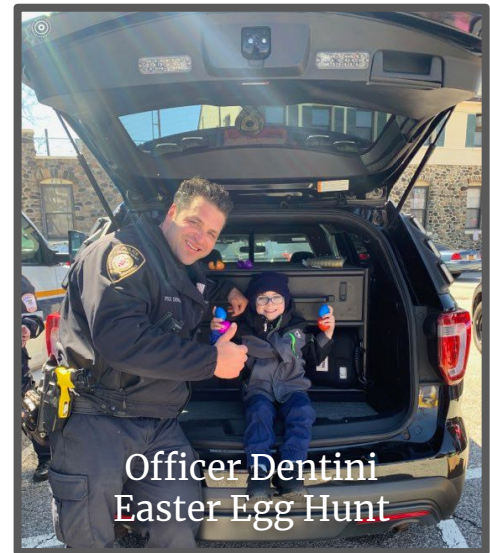
