

CRIMES BY CLASSIFICATION

FELONIES – offense punishable for which a sentence to a term of imprisonment in excess of one year may be imposed

- There were three (3) felonies reported in March:

BURGLARY

- a) unlawfully enter a dwelling with intent to commit crime within (2)

GRAND LARCENY

- a) theft of a credit card

MISDEMEANORS – any crime that carries a potential sentence of incarceration for more than 15 days but no more than 364 days

There were six (8) misdemeanors reported in March as follows:

TRAFFIC COMPLAINTS (7)

- a) aggravated unlicensed operation (2) **ARREST(1)**
- b) operating with a suspended registration (4)
- c) driving while intoxicated **ARREST**

COURT ORDER

- a) violation of order of protection **ARREST**

VIOLATIONS – offense other than traffic infraction for which a sentence to a term of imprisonment of up to 15 days may be imposed

There were no violations reported in March.
