Training Highlights

Active Shooter response and specialized youth and community resource officer training were the focus of the third quarter training cycle. We were able to certify a new Advanced Juvenile Officer, a Community Resource Officer and an Advanced School Resource Officer through the State of New York Juvenile Officers Association. This training helps build a strong foundation for Community Policing going forward.

PoliceOne Academy Online Training

Officers completed approximately 5 hours of online training through PoliceOne Academy from July through September. Topics included Community Policing, Active Shooter 1 and Recognizing and Responding to Domestic Violence.

Departmental Training

Department Range Qualifications: Firearms training was held in September and covered Department issued Glock 22 handguns, Patrol Rifles and PepperBall Less Lethal weapon.

Specialized Training

State Of New York Juvenile Officers Association Conference:

Chief Satriale, LT Bunyan, SGT DeYoung, SGT Morgan, DET SGT Anderson, PO Dibenedetto and PO Stein attended the annual conference in Lake George. PO Dibenedetto attended Advanced School Resource Officer training, PO Stein attended Community Resource Officer training and SGT Morgan attended Advanced Juvenile Officer training. Chief Satriale, LT Bunyan, DET SGT Anderson and SGT DeYoung attended the Continuing Education Workshop Series with classes covering Responsive Leadership, Legal Updates, Threat Assessment Teams and Identifying Drug Trends in Schools.

New York Tactical Officers Association Conference:

Sgt DeYoung and PO Stein attended the annual New York Tactical Officers Association Conference in Verona NY. PO Stein attended the Patrol Tactics portion of the conference. Training included Plain Clothes Handgun Tactics, Active Threat Incidents, Building Clearing Tactics and 2 Officer Apprehension Tactics.

Law Enforcement Training Directors Association of NY State Conference:

Sgt DeYoung attended the annual conference of the Law Enforcement Training Directors Association in Geneva, NY. The conference included training and seminars on Contemporary Legal Issues for Police Trainers, Use of Force and Training, Officer Wellness and Procedural Justice Initiatives.

Emergency Response Unit Tactical Training: Sgt DeYoung attended 32 hours of tactical training as part of his obligation to the Emergency Response Unit. Training included Active Shooter Response, Combat Leadership, Barricaded Suspect Resolution and High-Risk Warrant Planning.

Tactical Emergency Casualty Care:

DET SGT Anderson, SGT DeYoung and PO Stein attended an 8 hour Tactical Emergency Casualty Care course hosted by Medicine in Bad Places. The course was hosted for Police Officers and taught basic medical care interventions that will help save the lives of Officers, as well as the public.

The course covered the strategies for hemorrhage control, including the use of tourniquets and hemostatic dressing. Also taught were the basics of Tactical Emergency Casualty Care, including airway control techniques and treating indicators of shock.

Total Training Hours by Officer

Officers completed an average of 28.2 hours of training for the months July through September 2021.

Quarter 4 Training Projections

The Quarter 4 training cycle will continue our Active Shooter training. A joint department Active Shooter training event is scheduled with the surrounding jurisdictions of Tuckahoe PD and Eastchester PD. The training will cover current tactics for responding to Active Shooter and mass violence events and will include classroom instruction followed by force-onforce simmunitions scenarios.
